One of the main aspects EU trying to improve is entrepreneurship however there is big difference between EU countries regarding Entrepreneurs conditions, support and role.

If there is a country where self-employment has specific weight in the labour market, that is Spain. Specifically, the self-employed make up 18.3% of the workers affiliated with Social Security and 27.6% of the total employment according to the latest figures provided in Congress, make Spain the third country in Europe in terms of rate of self-employed workers on the total market, only surpassed by Italy and Portugal.

Promoting self-employment and entrepreneurship is one of the priorities at national and European level, however despite the large number of SMEs, in Spain 47% of self-employed workers fail in 3 years and 62% after 5 years. Very high data. On the other hand, another problem that our economy carries is the one known as the underground economy, which accounts for 25% of GDP where Spain is double the European average.

The aims of this project are:

- Know the situation in every country regarding entrepreneurs.
- Develop joint proposals that promote the improvement and democratic participation of young people, as well as the breaking down ideas of inaccessibility by decision makers.
- Raise awareness about the realities of each country, emphasizing the situation of self-employment and the underground economy
- Show the support of the European Union through Participatory action as a transformation tool.
- Dialogue with political leaders and decision makers to inspire and get aware about other countries ideas.
- Awaken responsibility and involvement in the political life of young people for their participation in democratic life.
